Report from Governing Council

2014 was a year of change for the Booleroo Centre and District Kindergarten, with implementation of the 15 hours of Universal Access, implementation of the Same Day Policy intake and initiation of the Preschool Associated program.

The year commenced with a visit to both Booleroo Centre and Melrose sites by DECS officials on February 19th. Namely, Kathryn Jordan (Director Early Childhood Services), Helen Leo (Manager Preschool Policy and Programs) and Jess Arbon (Early Childhood Leader, Flinders Partnership) for an Early Childhood Service Consultation. This was well attended by parents. A working group of two representatives from each town was formed. The purpose of this group was to review and action recommendations from the consultations and explore a future model of early childhood services considering declining kindergarten numbers across some of the towns.

The preschool service at Melrose continued not to reopen, despite ongoing campaigning by Melrose parents and the wider Melrose community. Despite this, Rural Care at Melrose continued for 5 days a week, the Melrose Play Centre (financially supported by Melrose Primary School for 3 hours and 3 hours from DECD) was also operational on Wednesdays and playgroup continued at the Melrose integrated site.

Mrs Jenny Stringer continued on as Director, despite also assuming the position of Principal of Booleroo Centre District School. Existing rural care staff at Booleroo Centre and Melrose were employed in an additional capacity to take on duties in relation to Rural Care operations. Rachel Girdham was also employed mid-year to support with implementation of some administrative policy and procedural work. Booleroo Kindergarten secured Angela Hamlyn as teacher. This initially commenced as a term by term contract, but fortunately for the children, she continued in the position for all four terms providing much needed continuity. She worked closely alongside Karen Blesing as ECW and other staff to ensure that the Kindergarten ran smoothly. The arrangement of one person assuming both the Principal position of Booleroo Centre District School, the Kindergarten and Rural Care, was a concern to the parents. The parent group did voice this concern, however DECD human resource procedures meant that this continued for the entire year.

The Same Day Policy intake for 2014 meant that all kindergarten students born after May 2009, but before April 30th 2010 commenced together in Term one, 2015. This included some Melrose families who chose to send their children to Booleroo Centre. The preschool program consisted of 15 hours a week, which spanned over two full days (Tuesdays and Thursdays) and one half day every alternate Friday.

The Same Day Policy intake for 2014 also had implications for Rural Care, in that there were fewer rural care positions available throughout the year (due to the decreased movement of kindergarten students to school each term) and more places available at the end of the year. This meant Rural Care staff had to anticipate and plan ahead for this explosion of work at the end of the year, in managing the waitlists, by starting a dialogue with families early in Term 4 about their child's anticipated transition to school.

Towards the end of term three, there was interest expressed from parents of children commencing school in 2015 for the need for more after school care. This resulted in parents being formally surveyed to examine the need further. Unfortunately, for those families who indicated the need for after school care, insufficient interest was obtained to extend after school care places entering 2015.

The Preschool Associated Program was implemented following enquiries from parents. This is an additional service now offered at Booleroo Centre Kindergarten upon negotiation with the Director to support children with additional needs or special circumstances; for example, allowing a child to start the program prior to commencement of Kindergarten. A Preschool Expression of Interest form was distributed to families to determine their preferred preschool sites, to predict numbers for future enrolments.

Booleroo Centre and Melrose Rural Care were fortunate to obtain funding for \$2500 at each site for resources targeting birth to two year old children accessing care. Parents were consulted on and valuable resources secured. Five hundred dollars of OPAL grant funding was also obtained for the purchase of a pedal bike and large blocks and mobile phones provided to each site.

As a committee we also had to decide on who should be nominated for the inaugural Booleroo Centre and Districts Kindergarten Volunteer award. Despite a wide range of volunteers assisting in different ways throughout the year; the committee felt that David Prosser stood out as an initial winner, for his tireless work at the kindergarten over numerous years in the grounds, undertaking a great deal of 'behind the scenes' work.

I would like to take this opportunity in thanking the volunteer parents on our committee (whom the majority were new to the committee) and those who may have volunteered during the year in various roles or assisting with activities (planting grass, pruning trees, accompanying excursions). I would also like to thank the staff who worked tirelessly throughout 2014 to improve the service available in the community, whilst adapting to a significant amount of change in order to support our children's healthy learning and development.

Both the Booleroo and Melrose Rural Care centres are maintaining Full Time Equivalences (FTE) above 3.9 FTE. 3.9 is the viability figure for a Rural Care Centre across the state. Combined with after school care and with the maximum of 4 children under school age; gives rise to the average figures for both centres. There is a waiting list for both centres, however to employ another ECW2 to make an extra session we need to have 10 FTE to guarantee sustainability. The extra 6 children pay for the ECW2 salary for care. DECD fund the initial ECW2, however any subsequent employment of ECW2s is a site expense. Parents were surveyed in 2014 to ascertain any change in care needs for the geographical area.

Parent concern from other towns often focusses on a preschool such as Booleroo Centre and District Kindergarten's ability to transition to schools other than Booleroo Centre District School. This tabulated data indicates the capacity for transitions to other sites, with regularly organized sessions within the destination school and sharing of information between staff enabling children to enter school of choice smoothly.

Client Opinion

Parent opinion was gathered with regard to Rural Care needs for Before School Care, After School Care, Holiday Care and the care positions available after the half day kindy session every fortnight. The emphasis of the surveys was to determine whether it was possible to run another after school session at Booleroo for school aged children. The difficulty which presented itself was that not each family needed

the same day for care and whilst there were groupings of family needs, 6 families in addition to the 4 families already using care were required to make it economically viable. In essence we need a guarantee of 10 children to use the service to have two early childhood workers contracted. This will need to be a survey that is carried out periodically to determine if family's needs have changed over time.
